6.1 SARAN

1. Sebaiknya struktur organisasi Instalasi Farmasi Rumah Sakit (IFRS) RSUD Kabupaten Sidoarjo tetap mempertahankan peran, fungsi, posisi dan tanggung jawab sesuai dengan Peraturan Menteri Kesehatan RI No. 72 tahun 2016 tentang Standart Pelayanan Kefarmasian di Rumah Sakit.
2. RSUD Kabupaten Sidoarjo belum melakukan kegiatan PKOD dan penanganan obat-obat sitostatika.
Solusi : Disarankan untuk kedepannya mahasiswa diberikan pembekalan tentang PKOD maupun penanganan obat-obat sitostatika.
3. Tempat melakukan penyuluhan di Farmasi 5 dan Farmasi 8 belum kondusif karena bersamaan dengan pengambilan obat.
Solusi : Adanya tempat khusus untuk penyuluhan terhadap pasien tunggu di farmasi 5 dan farmasi 8, agar pasien dapat lebih optimal dalam menerima materi penyuluhan yang disampaikan.
4. Sebaiknya kesempatan dalam menjalani pembelajaran di rawat inap oleh mahasiswa PKPA mendapatkan dua bangsal sehingga dapat memahami pola penyakit dan pengobatan yang berbeda di tiap bangsal.
Solusi : Sebaiknya mahasiswa dapat diberikan kesempatan untuk pembelajaran lebih dari dua bangsal.
5. Mahasiswa masih belum cukup siap saat pertama kali diberikan kesempatan dalam pembelajaran di rawat inap inap.
Solusi : Sebaiknya dapat diberikan *briefing* atau matrikulasi mengenai pembelajaran di rawat inap.
6. Pembekalan mengenai CSSD masih belum mendapatkan kesempatan sebagai pembelajaran PKPA mahasiswa, meski jadwal sudah tercantum sebelumnya.
Solusi : agar dapat dikoordinasikan lebih lanjut mengenai pembekalan di CSSD jauh hari dengan baik agar terlaksana sesuai dengan jadwal yang telah ditentukan.
