

CHAPTER 5

CONCLUSIONS AND SUGGESTIONS

This chapter will briefly conclude all points discussed in the previous chapters which were the answers of the research questions. Besides, it also gives the suggestions for both the teacher and the future researchers.

Conclusions

This study is aimed to cater to the needs of professionals in learning English to support their job with the limited time available. Therefore, the design of the syllabus must focus on the materials that they will use in their corporate daily operation in the port business. The syllabus and the materials were designed using ADDIE model which stood from Analyzing, Designing, Developing, Implementing and Evaluating. In the needs analysis stage during the interview with the training department and experts in operation departments, it was found that the ten topics were needed in practicing their English in oral basis. The program was designed for one term with fifteen meeting for ninety minutes each. The syllabus and materials had been reviewed by the expert of the port business. The order of the materials

presented was based on the scope, from the small to the broad ones. One material was tried out to specific group of learners resembling the target group, and the learners showed positive remark on both of the materials and the delivery.

Suggestions

Further study on materials development is suggested on the other field in maritime and logistic business such as the transportation, the maritime safety and possibly to expand to the broader profession. It is necessary to create materials that suited with the professionals' limited time and energy to learn English, therefore the best formula should be further investigated in more advanced research studies.
