

BAB 6 **KESIMPULAN DAN SARAN**

Bab ini menjelaskan tentang kesimpulan dari hasil penelitian yang merupakan jawaban atas tujuan penelitian. Selain itu terdapat saran yang bersifat praktis dan aplikatif sebagai tindak lanjut dalam penelitian ini.

6.1 Kesimpulan

Penelitian ini melibatkan 12 orang partisipan individu lanjut usia dengan DM yang memiliki pengalaman dalam menjalani terapi hipoglikemi oral dan insulin secara mandiri. Rentang usia partisipan 61 tahun sampai 77 tahun, dengan rerata usia yaitu 67.5 tahun. Lama mengalami DM antara 2 tahun sampai dengan 24 tahun. Partisipan berjenis kelamin laki-laki sebanyak lima orang, dan perempuan sebanyak tujuh orang

Hasil penelitian tentang pengalaman pasien Diabetes Melitus lanjut usia dalam kepatuhan dan menjalani *self care* terapi hipoglikemi oral dan insulin mendapatkan enam tema yaitu: *self adjusment* dalam pemberian obat DM, *self control* dengan penyuntikan insulin, penyuntikan insulin memberikan harapan dalam mengelola kadar gula darah, masalah psikologis akibat terapi jangka panjang, tidak menyadari dampak negatif dari ketidakpatuhan, pengaruh proses penuaan terhadap kemampuan *self care* pengobatan. Tema tersebut menggambarkan pengalaman individu lanjut usia dalam kepatuhan dan menjalani *self care* pengobatan dengan oral hipoglikemi dan insulin.

Tema *self adjusment* dalam pemberian obat DM dan *self control* dengan penyuntikan insulin menggambarkan kebutuhan yang khusus dalam pengobatan bagi individu dengan penyakit kronis berusia lanjut dan harus menjalankan pengobatan seumur hidupnya dengan patuh. Partisipan penelitian yang mengalami DM lebih dari 10 tahun mengungkapkan pengalamannya dalam menjalankan pengobatan sesuai dengan kebutuhan yang dirasakan melalui *self adjusment* dalam pemberian obat DM dengan cara menentukan waktu minum obat dan dosis obat yang harus dikonsumsi dalam sehari. Pengalaman *Self control* dengan

penyuntikan insulin pada partisipan penelitian dilakukan dengan cara menentukan dosis insulin serta jadwal pemberian sesuai dengan kebutuhan yang dirasakan. Berdasarkan pengalaman tersebut, maka kesimpulan dari penelitian ini adalah: ketidakpatuhan selama menjalankan terapi hipoglikemi oral insulin pada lanjut usia dengan Diabetes Melitus tipe 2 tidak disadari, sementara pengalaman dalam menjalankan *self care* dipengaruhi oleh proses penuaan.

6.2 Saran

6.2.1 Bagi Institusi Pelayanan Keperawatan

Fenomena yang ditemukan di lapangan menggambarkan kepatuhan individu lanjut usia dengan DM dalam menjalankan pengobatan dengan oral hipoglikemi maupun insulin sedemikian rumitnya. Kepatuhan tersebut berdasarkan pengalaman selama menjalankan pengobatan mampu mengontrol kadar gula darah dalam batas yang dirasakan nyaman bagi individu. Maka, diharapkan pelayanan Keperawatan Medikal Bedah mampu menentukan bentuk pelayanan keperawatan sesuai tingkat usia terutama pada individu lanjut usia dengan penyakit kronis dan harus menjalani pengobatan seumur hidup yang sifatnya individual. Sehingga, individu dapat meningkatkan kepatuhan serta kemampuan *self care* dalam pengobatan karena keyakinan dan efikasi diri yang baik pada pasien DM lanjut usia dalam menjalankan pengobatan.

6.2.2 Bagi perkembangan Ilmu Keperawatan

Penggambaran fenomena kepatuhan selama menjalankan terapi hipoglikemi baik oral maupun insulin pada individu lanjut usia diharapkan dapat menjadi masukan bagi pendidikan keperawatan medikal bedah dalam proses pembelajaran mahasiswa. Proses pembelajaran tersebut terutama dalam merencanakan asuhan keperawatan yang lebih komprehensif pada individu lanjut usia dengan DM. bahwa kepatuhan menjalankan pengobatan dipengaruhi berbagai faktor seperti tingkat pendidikan individu dalam kemampuan memahami pengobatan, manfaat serta penyakit kronis yang dialami; efikasi diri; keyakinan pada pengobatan yang dijalani. Maka, ilmu keperawatan dituntut mampu membuat kerangka pembelajaran asuhan keperawatan pada individu lanjut usia melalui intervensi keperawatan yang mampu meningkatkan kesadaran diri tentang adanya

ketidakpatuhan dan melatih *self care* yang tepat dalam menjalankan terapi hipoglikemi oral dan insulin sebagai bagian dari pengelolaan pada individu lanjut usia dengan DM.

6.2.3 Bagi penelitian selanjutnya

Hasil penelitian ini dapat menjadi data dasar bagi penelitian selanjutnya. Penelitian tentang intervensi yang tepat untuk meningkatkan kesadaran diri tentang adanya ketidakpatuhan dalam menjalankan terapi hipoglikemi oral dan insulin pada individu lanjut usia dengan DM. Penelitian lain lagi yang mungkin dilaksanakan tentang melatih kemampuan *self care* yang tepat dalam menjalankan terapi hipoglikemi oral dan insulin sebagai bagian dari pengelolaan pada individu lanjut usia dengan DM.
