CHAPTER V

CONCLUSION AND SUGGESTION

In this chapter, the writer tries to make a conclusion of all the analysis in chapter IV. Beside that the writer provides as well some suggestions for the following researcher especially as English students who are interested in studying literature particularly play.

5.1 Conclusion

Relating to the discussion of George Bernard Shaw's "Mrs. Warren's Profession" in chapter four, the writer tries to withdraw a conclusion. Because the purpose of this study is to analyze the motivation of Mrs. Warren as the main character to have a profession as a lady of entertainment, the writer would like to present the conclusion in accordance with the purpose.

Basically every human being has motivation to gain his goal because motivation is the combination of desire, values, and beliefs that drive someone to take action. So, those three combinations can influence someone's motivation as well. In addition, individuals are motivated by the desire to fulfill inner needs which is related to human motivation or human needs. They are: physiological needs, safety needs, social needs, esteem needs, and self-actualization needs. These needs also affect Mrs. Warren as the main character in "Mrs. Warren's Profession" to have motivation to gain her goals by being a lady of entertainment.

With reference to the statement of the problem about "What are the motivation of Mrs. Warren to have a profession as a lady of entertainment?", it is proved that basically there are only three kinds of Mrs. Warren's motivation to have a profession as a lady of entertainment in "Mrs. Warren's Profession". The first one is to achieve a high standard of living, plenty of wealth and money. The second one is to raise to the higher social status so she becomes a socially respected and accepted lady. And the third one is to give her daughter, Vivie, a comfortable and contented life, and a first-rate education which can also make Vivie a respected lady. From the answers found above, the writer assumes that Mrs. Warren has fulfilled her inner needs. It is related to Maslow's theory that individuals are motivated by the desire to fulfill inner needs which is related to human motivation. So, according to Maslow's hierarchy of human needs, the writer of this study finds that Mrs. Warren has gained four human needs of five levels of human needs. They are physiological needs and safety needs by which Mrs. Warren has achieved a high standard of living, plenty of wealth and money so she can eat three times a day by which the meal is prepared, buy a new dress, have a big house, get a comfortable life, and get everything she wants easily. Moreover, by having a profession as a lady of entertainment and being a rich woman, Mrs. Warren does not take the same lane as what her two half sisters have taken which are so frightful being a factory worker and so disheartened being a wife. So, Mrs. Warren feels secure in her profession because she gets a relatively high wage with easier working condition, and successfully, she can protect Vivie from a wretch life by taking vivie in a good school and giving her plenty of money to fulfill her living needs, so she will not be like her mother. Then, social needs and esteem needs by which finally Mrs. Warren can raise her social status higher so she becomes a socially respected and accepted lady. She is no longer a poor starving girl instead she is a beautifully dress well-fed woman. Finally, she gets her pride back and even much higher than before. Therefore, she is never ashamed of what she has done and never care of people's opinion about her job because she feels confident that this profession is not totally bad as long as it is handled with good managing from which she finally becomes a rich respected woman with plenty of wealth and money which can fulfill her living needs well and she also bring her daughter up lucratively. She gives her daughter a comfortable and contented life, and a first-rate education in an expensive school; it is Cambridge, which can also make her daughter a respected lady.

Based on the explanation above, the writer of this study assumes that actually Mrs. Warren has gained ideals successfully even though she does not get her daughter's love entirely because Vivie knows that her mother's profession has not wound up yet, even Mrs. Warren will keep doing it until she dies. So, Mrs. Warren feels rather disappointed and unhappy when Vivie rejects her.

Basically, even though every human being has motivation to gain his goal, he never feels satisfied of what he has got, he always wants a perfect life, and even many people in this world will do anything for the sake of getting a perfect life. It means that if they have satisfied the basic needs, they want to achieve the higher needs, and so on. They will keep trying to satisfy all their needs to get a perfect life. Logically, it shows that human being is an arrogant creature. So, as

what Mrs. Warren has got such as her success in being a rich woman, raising her social status and giving her daughter a comfortable life is not her final goal. However, it is one of her many purposes in life. It is because human needs are unlimited.

In short, Mrs. Warren's story of her difficult childhood and struggle to gain a comfortable life for herself and her daughter illustrates her survival, her patience and her lack of regard for social retrains reveals her courage. Her best role is to become a devoted mother which she trots out in front of Vivie when she shows no sympathetic understanding of her mother's choice of profession. Her love and struggle for her daughter becomes an evident, even though, she feels hurt when Vivie rejects and does not respect her. Mrs. Warren loves Vivie with all her heart. Besides, Mrs. Warren convinces herself that prostitution is not a bad life for a woman. She truly helps the girls she employs to get better themselves with a better life. Ultimately, Vivie forces her to face the reality which happens in her life, and Mrs. Warren must admit that Vivie has grown too, so Mrs. Warren does not consider Vivie as a child anymore.

5.2 Suggestion

The writer hopes that this study can give inspiration, especially, for students of English Department of Widya Mandala Catholic University who take literature as their study. The writer feels that one of George Bernard Shaw's biggest plays, "Mrs. Warren's Profession", is interesting to be analyzed further

because it discuses about a moral study of human's life problem which can happen to every body.

Based on the findings on the motivation of Mrs. Warren to be a lady of entertainment in George Bernard Shaw's "Mrs. Warren's Profession", it can be seen that the analysis includes Mrs. Warren's motivation to have a profession as a lady of entertainment. However, there are still many aspects that have not been discussed such as theme, setting, plot or the conflict between Mrs. Warren as the mother and Vivie Warren as the daughter, and other characters. The writer suggests that the other students who are interested in similar study can select one of the aspects that have been mentioned above because this study is the new topic which has never been discussed before by the students of English Department of Widya Mandala Catholic University.
