Reviewer Reports

Reviewer 1	
Grade	B - This paper is acceptable. Minor improvements can be done in terms of organization/language/literature review etc. Some further comments are given below.
Comments	The paper is quite well written. The introduction is a bit short on references. The links between the data collected and the discussion needs to be clearer as it is not obvious in some places how conclusions were arrived at.

Grade	D - This paper needs a major revision before acceptance can be considered. In particular, the authors need to consider the following comments
Comments	<p>This paper needs a major revision before acceptance can be considered. In particular, the authors need to consider the following comments.</p> <p>I. The abstract is poorly written. The abstract should include the method used and new results found clearly. The abstract needs to provide practical implications, research limitations, and future directions.</p> <p>II. Lack of clarity and poor academic writing.</p> <p>III. There is no consistency in the in-text citation. Need proper referencing according to the guideline provided. There are missing in-text citations. (eg: In 2016, Indonesia has the largest coconut palm growing areas in the world covering 3.65 million hectares followed by the Philippines with 3.57 million hectares of coconut plantation. In the last few years, the area planted to coconut in Indonesia was observed to be at a generally decreasing trend (Reference).)</p>

	IV. This paper title with the keyword "sustainability issue". But paper lacks justification about the sustainability concept and how it related to the coconut supply chain.
Reviewer 3	
Grade	B - This paper is acceptable. Minor improvements can be done in terms of organization/language/literature review etc. Some further comments are given below.
Comments	<p>This paper explored the sustainability issues of the coconut supply chain in Indonesia through online news articles using content analysis and binary factor analysis.</p> <p>This paper can be accepted with some changes, e.g., 1) "Indonesian coconut" was used as the keyword of the Google search engine, however, the news articles selected are those written in Indonesian language. Maybe can explain how about other keywords and why only Indonesian language; 2) Need to explain why scientific articles are also excluded, what about those scientific articles related to "coconut sustainability issues"? Maybe they are useful to authors' study too; 3) In section 1, it mentioned the dimming interest toward coconut commodities in Indonesia and less attractive research, need to explain the motivations of this paper, and why turned into online news for answers; 4) Under section IV, the discussions should link to the conclusions better, e.g., coconut production and productivity, disruption in the coconut value chain and government interventions etc.</p>
