CHAPTER V

CONCLUSION AND SUGGESTION

Chapter V is the final chapter of the study to make a conclusion from the analysis. In addition, the writer also gives some suggestions for the students of English Department who are interested in studying literature, especially in studying the drama.

5.1 Conclusion

This study discusses one of Henrik Ibsen's plays entitled *Ghost*. In this study, the writer analyzes the symbols of light and darkness.

From the first question of the statement of the problem concerning the symbol of light, the writer reveals that the symbols of light for Oswald Alving are truth, love and self-expression. Oswald Alving, although important in the play, was merely a minor character and represented the doomed product of a diseased society. As the writer analyzed the play, the writer found that light has several meanings. First, it refers to truth that Oswald always wants to know. Second, light refers to love and self-expression that Oswald tried to find. The last, light refers to life. Life that Oswald hoped to end the lingering disease in his forehead.
