CONCLUSION AND SUGGESTION

This chapter is intended to conclude the analysis of the previous chapter. It also gives some suggestions which may be useful for those who are interesting in studying and analysing the novel from different angle of discussion.

5.1. Conclusion

This study discusses a novel entitled <u>Little Women</u>.
