

In view of such matters, the writer performs a study of the theme in John Steinbeck's novel: The Grapes of Wrath.

Considering that Steinbeck is one of the recognized and influencial authors in America history, the writer then chooses his awarded novel, The Grapes of Wrath as her thesis subject. To this point, Steinbeck's novel reflects his primary concern over humanity with all its nature and phenomena.

This study is expected to answer the following research questions: (1) How is the connection between character and theme. (2) How is the connection between plo and theme. (3) How is the connection between setting and theme. (4) What is the theme of the novel.

this thesis deals with the revelation in The Grapes of Wrath, the use of the objective as well as the analytical method is needed.
