## **2. Kino's Ideology**

External conflict does not happen among the individual characters. In *The Pearl*, the conflicts involve the group of people from two clusters: low economic level and high economic level, in which each of groups represent what ideology they have. For example when Kino's purpose to sell the pearl to be a rich man, it reflects his characteristic as a liberalist. In contrast with Kino, the doctor, who is a capitalist, shows his oppression to Kino by rejecting the treatment for the baby only because of Kino's poverty.
