



BAB 5

KESIMPULAN DAN SARAN

5.1 Kesimpulan Praktek Kerja Profesi Apoteker

Berdasarkan kegiatan Praktek Kerja Profesi Apoteker di RS Universitas Airlangga Surabaya, pada tanggal 1 Oktober sampai 30 November 2019, dapat disimpulkan bahwa:

1. Praktek Kerja Profesi Apoteker di RS Universitas Airlangga Surabaya mampu meningkatkan pemahaman calon apoteker tentang peran, fungsi, posisi dan tanggungjawab apoteker dalam pelayanan kefarmasian di Rumah Sakit.
2. Fungsi dan peran apoteker di RS Universitas Airlangga Surabaya dari segi manajerial adalah melakukan pemilihan, perencanaan, pengadaan, penerimaan, penyimpanan, pendistribusian, pengendalian, penarikan dan pemusnahan serta dokumentasi (administrasi) sediaan farmasi, alat kesehatan dan bahan medis habis pakai. Kemudian untuk pelayanan kefarmasian di RS Universitas Airlangga Surabaya meliputi pengkajian dan pelayanan resep, penelusuran riwayat penggunaan obat, rekonsiliasi obat, pelayanan informasi obat, konseling, visite, pemantauan terapi obat, monitoring efek samping obat, evaluasi penggunaan obat telah sesuai dengan Peraturan Menteri Kesehatan Republik Indonesia Nomor 72 Tahun 2016 tentang Standar Pelayanan Kefarmasian di Rumah Sakit.
3. Proses pengelolaan sediaan farmasi di RS Universitas Airlangga Surabaya menggunakan system satu pintu, yaitu sistem dimana semua sediaan farmasi, alat kesehatan dan bahan medis habis pakai yang digunakan di RS Universitas Airlangga Surabaya dikelola oleh instalasi farmasi.

5.2 Saran Praktek Kerja Profesi Apoteker

Saran yang dapat diberikan setelah melaksanakan PKPA di Instalasi Farmasi Rumah Sakit Universitas Airlangga Surabaya, antara lain:

1. Rumah Sakit Universitas Airlangga Surabaya berkenan menambahkan waktu PKPA sehingga mahasiswa calon Apoteker dapat semakin memahami peran dan fungsi Apoteker di Rumah Sakit.
2. Kegiatan Farmasi Klinis di Instalasi Farmasi RS Universitas Airlangga Surabaya seperti yang tertera dalam dengan Peraturan Menteri Kesehatan Republik Indonesia Nomor 72



Tahun 2016 tentang Standar Pelayanan Kefarmasian di Rumah Sakit sangat beragam dan sudah berjalan dengan cukup baik. Untuk mengoptimalkan pelayanan farmasi klinis baik secara kualitas maupun kuantitas maka perlu dilakukan penambahan apoteker yang melaksanakan kegiatan farmasi klinis tersebut.
