

BAB V

KESIMPULAN DAN SARAN

5.1 Kesimpulan

Berdasarkan hasil kegiatan Praktek Kerja Profesi Apoteker yang telah dilakukan di Apotek 24 Medika Madiun pada tanggal 17 Agustus – 29 Agustus 2020 didapatkan kesimpulan sebagai berikut:

1. Seorang Apoteker memiliki peran, fungsi, posisi, dan tanggung jawab yang besar dalam menjalankan pekerjaan kefarmasian di apotek.
2. Seorang Apoteker harus menguasai segala aspek (baik dalam pelayanan maupun managerial) dalam menjalankan pekerjaan kefarmasian di apotek.
3. Praktek Kerja Profesi Apoteker di Apotek memberi bekal pengetahuan, pengalaman dan ketrampilan praktis kepada calon Apoteker tentang pekerjaan kefarmasian yang dilakukan di Apotek.
4. Praktek Kerja Profesi Apoteker di Apotek memberi gambaran nyata tentang permasalahan pekerjaan kefarmasian di apotek.
5. Praktek Kerja Profesi Apoteker di Apotek dapat memberikan pengalaman untuk memasuki dunia kerja sebagai tenaga kefarmasian yang profesional.

5.2 Saran

Saran yang dapat disampaikan setelah menyelesaikan Praktek Kerja Profesi Apoteker (PKPA) di Apotek 24 Medika Madiun adalah sebagai berikut :
