

CHAPTER 5

CONCLUSION AND SUGGESTION

5.1 Conclusion

Analyzing of the novel, the writer would like to propose conclusions. First, the writer concludes the self-image of Dr. Jekyll affects the development of his personality. Dr. Jekyll saw himself as a perfect doctor figure with good personality. He also had difficulties in showing his true self, including his 'dark' side because of the 'always' good image that he had. Based on Jung's archetype, the shadow is the dark side of the human ego and part where the evil side was stored. Dr. Jekyll's evil part arose because he could not 'show' it like what other people did. He always suppressed it although he knew that every human being had two sides of personality. The shadow also represents the animal side of human that was showed on how Mr. Hyde reacted in meeting someone new.

In the novel, Dr. Jekyll did not showed lot of emotion. This thing can increase problem inside a human being since the rational side and emotional side was imbalanced. To overcome his problem, Dr. Jekyll created Mr. Hyde that dominantly showed emotional side of him.
