

CHAPTER V

CONCLUSION AND SUGGESTIONS

This chapter consists two major parts, i.e. the conclusion and the suggestion. Based on the research findings, the conclusion is directed to answer the research questions. In the section of suggestion, the findings-based suggestions are presented. The suggestions are dedicated to the teaching and learning of CALT course and further study. The suggestions for the betterment of the teaching and learning of CALT course are addressed to the English Language Education Study Program, the lecturers teaching CALT, and the students attending the course. The suggestions for further study is addressed to those who plans to conduct a study of related topic.

5.1 Conclusion

The purpose of my study is to share what I learnt in online CALT class. Other than that, it is aimed to share my improvement on the online learning material development skill. This study is based on my experiences on attending the online CALT class.

In the findings, I discuss about two ideas. They are the online platforms and the discussion. I explain about all of the online learning platforms that I learnt by giving brief explanation and also explaining my assignments. I also share my experience on doing the assignment using each tool. Along with the experience, I write the difficulties that I encountered on doing the assignments.

On the discussion, I separate the ideas into two sub topics; the connection of the theories that I used with my online CALT class and how my online learning material development skill improve.
