### **KESIMPULAN DAN SARAN**

#### **5.1. Kesimpulan**

1. Pemberian asam 2-(3-(klorometil)benzoiloksi)benzoat dapat meningkatkan rasio sel limfosit-T  $CD3^{pos}CD4^{pos}CD25^{pos}$  pada mencit putih (*Mus musculus*) galur swiss webster yang diinduksi inflamasi menggunakan Lipopolisakarida (LPS).
2. Pemberian asam 2-(3-(klorometil)benzoiloksi)benzoat dapat meningkatkan rasio sel limfosit-T  $CD3^{pos}CD8^{pos}CD25^{pos}$  pada mencit putih (*Mus musculus*) galur swiss webster yang diinduksi inflamasi menggunakan Lipopolisakarida (LPS).

#### **5.2. Saran**

1. Melakukan pengukuran terhadap marker Foxp3 untuk mengetahui populasi dari sel T regulator  $CD3^{pos}CD4^{pos}CD25^{pos}Foxp3^{pos}$  dan  $CD3^{pos}CD4^{pos}CD25^{pos}Foxp3^{neg}$ .
2. Melakukan penambahan durasi perlakuan untuk mengetahui efek pemberian senyawa asam 2-(3-(klorometil)benzoiloksi)benzoat pada populasi sel limfosit-T  $CD3^{pos}CD4^{pos}CD25^{pos}$  dan  $CD3^{pos}CD8^{pos}CD25^{pos}$  pada penggunaan jangka panjang.
