5.1 Conclusion.

To answer the first statement of the problem, the writer concludes the Coriolanus' maturity has indeed caused him to face his downfall. The main characters maturity influence by his childhood. As the only son who live with a single parent, place these two people into a close relationship. Coriolanus is the only hope for his mother to be the best soldier. In Coriolanus play, the main character is a person with his high selfconfident. His tenet has aroused an egoistic, which bring him to many enemies. From the beginning of the play, there's a lot of contrast in the communication between Coriolanus and society. However, the main character is too blind to see that his position in the society is fragile. In all of his life, Coriolanus too concentrate in how to please his mother and please his pride for being valiant. Thus, he always fails to recognize the moments where he has put himself in a right position. This immature part becomes the dominant weakness from Coriolanus character. His short temper has always become the part of Corilanus character, but his willingness to manage his emotion has sent him to a worst life.

From the second question of the problem statement related to the main character with the other characters, the writer also concludes that the other characters have contributions to Coriolanus downfall. In the Coriolanus' play, William Shakepeare creates Coriolanus as the main character, which trapped, between his pride, his mother will and his politic rivals. Coriolanus character in the play is influenced and shapes to be a noble patriotic soldier. He comes from a noble family, and only lives with his mother. There is a close relationship between mother and son, thus creates dependence among Coriolanus and his mother. Volumnia as his mother, play the dominant part in coriolanus' life. The main character believe what he sees, thus he make a subjective judgement which finally hurts the people. The citizens in the play are illustrating as a group of people who are uneducated and easily get provocate. The villains in the play exploit their fury to get rid of Coriolanus. The two tribunes use the scheme by provoking the citizen against Coriolanus, while their position is in jeopardy. The Volscian general creates a conspiracy with the other friends to destroy Coriolanus before Coriolanus take charge his soldier. Even though, these villains are never meeting each other, they are in the same positions against Coriolanus. Their position is in danger because of Coriolanus. And they are able to read his character. Coriolanus' weaknesses become the perfect weapon for the antagonists to destroy him. They do the same pattern with different way in provoking Coriolanus' anger. They knew exactly how to make the main character uncontrolled, by humiliating him in public. Coriolanus pride being hurt, and he is in fury. These parts always send him into more problems and get closely into a tragic flaw. He fails to see his own weakness; thus he is unable to control it.
